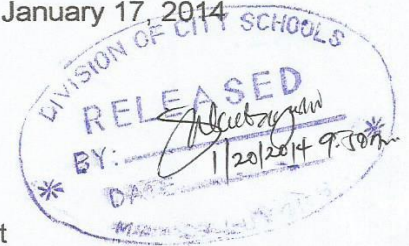

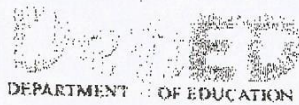

Theme: "Healthy Teeth, Healthy Smiles, Healthy Learners"

Who may enter?

The contest is open to public school children ages 6-9 at the time of entry. Employees of Colgate-Palmolive Philippines Inc. (CPPI) and their promotion and/or fulfillment agencies and immediate family members of these employees are not eligible.

Must artwork be original?

Yes. Artwork must be original, created by the pupil without assistance from others. Artwork cannot be copied or traced from a book or other material. Photos and computer-generated graphics will be disqualified.

What type/ medium of art entry is acceptable?

Black and white or color artwork depicting the theme "Healthy Teeth, Healthy Smiles and Healthy Learners" may be submitted: line drawings, crayon, paint, regular or colored pencil, acrylic pastel, magic markers, ink or any combination

What is the deadline for submission of entries?

Regional entries must be sent to Room 403, Dorm E; DepEd Complex, Meralco Avenue, Pasig City on or before June 10, 2014.

How should the entries be submitted?

The entry form may be photocopied. Entries should be mailed flat or in mailing tubes. Colgate-Palmolive Company is not responsible for lost, late or misdirected mail.

What size should the entry be?

Entries should be a minimum of 8.5 x 11 inches and must not exceed 11 x 17 inches.

Will entries be returned?

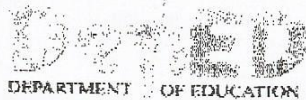
No. Entries become sole property of CPPI and will not be returned.

How will the entries be judged?

Entries will be judged on originality, creativity, imagination, and best rendering of the theme "Healthy Teeth, Healthy Smile, Healthy Learners.

CPPI and the Health and Nutrition Staff(HNC) will choose 9 winners. These winners will be submitted to the Global Judging for final selection of the 12 global winners to be featured on the Global Calendar.
