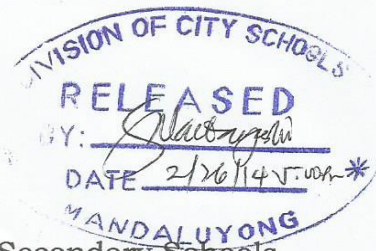

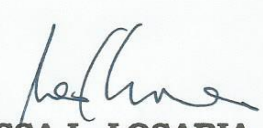
BALLET MANILA CONDUCTING SEASON PRODUCTION FOR 2014

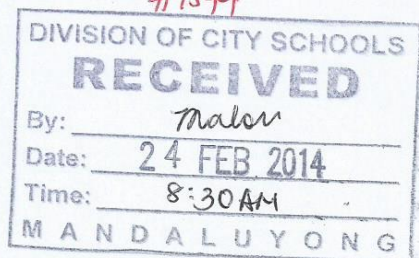
