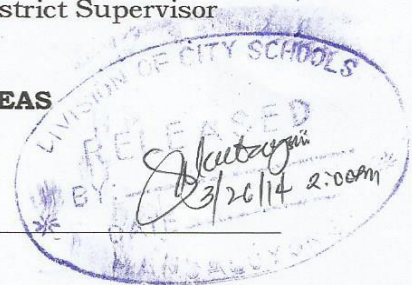


MEMORANDUM

1. As agreed upon during the Regional Planning Meeting conducted at Francisco Balagtas Elementary School last March 19, 2014, the following changes relative to the Unnumbered Memorandum issued on March 12, 2014, shall be made:

- a. The title of the activity will be *2nd Summer Reading Camp: Across All Learning Areas.*
- b. The March 24-25, 2014 schedule of the *2nd Summer Reading Camp: Across All Learning Areas* shall be moved to April 1 – 2, 2014 at the Quezon City Science Interactive Center, and
- c. The participants from the Division shall be the following:

d. Each participant will have to pay at the DepEd-NCR Cashier on or before March 31, 2014, a registration fee of Eight Hundred Fifty Pesos Only (Php850.00) instead of One Thousand Five Hundred (Php1,500.00) to defray the expenses for the camp kit (modules), supplies and materials, honorarium of speakers and other expenses relative to the conduct of the activity. This shall be charged against MOOE / Local Funds, subject to the usual auditing rules and regulations.

2. The Divisions' / Schools' implementation may be done from April 4 to 30, 2014 and should cover a minimum of 40 hours for the entire period.
3. The Action Plans pertaining to the above activity should be submitted on April 1, 2014 to the EED for the monitoring purposes of the Regional Office.
4. Further requested is the documentation of the Camp implementation to be done in hard and soft copies, and submitted to EED, DepEd-NCR on or before May 5, 2014.
5. Participants and working staff from the Regional and Division Offices may be awarded service credit / compensatory time off, as the case may be, according to the number of hours rendered. Attached is the list of the Working Committee.
