



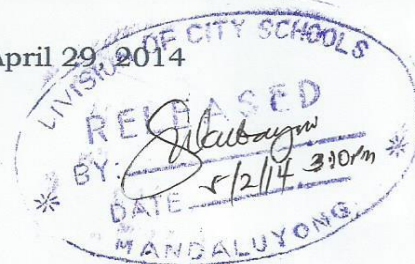

DEPED-NCR ATHLETIC DELEGATION TO THE 2014 PALARONG PAMBANSA

To: Schools Division Superintendents
Division Leader School Principals
Public and Private Elementary and Secondary School Principals

1. The DepEd-National Capital Region is now in its final stage of preparation for its participation in the Palarong Pambansa to be held on May 4-10, 2014 at Sta Cruz, Laguna. The athletic delegation, this region, is billeted at Liliw Central Elementary School, Brgy. Rizal, Liliw, Laguna.
2. The Region's participation in this national sports competition necessitates concerted effort and support of all sectors of the school system including that of the local government officials, NGOs, parents and the community as well. Schools Division Superintendents/Supervisors/School Heads, Teachers and other officials are requested to extend their assistance to their respective athletes and coaching staff to enable them attend to their training practices to ensure successful participation.
3. In view of the vital roles being played by the Regional and Division PESS Supervisors/Coordinators, it is requested that this national activity be given top priority in their assignments. Meantime, aside from their duties and responsibilities in their respective division, it is further requested that they give maximum attention to their respective athletes and to the delegation's needs.
4. Likewise, all Division PESS Supervisors are tasked to monitor the training of athletes in the sports events assigned to them and the actual competition in the duration of the Palarong Pambansa.
5. To boost the morale of the our athletic delegation, a PEP RALLY will be conducted on April 23, 2014, 1:00 p.m. at the Caloocan High School Gym, Caloocan City.
6. For a systematic and orderly transport, all Schools Divisions will take charge of bringing their athletes on April 29, 2014 and bringing them back to their respective schools divisions on May 11, 2014. This activity should be done in coordination with Mr. Tereso DI. Ubungin, Jr., DepEd-NCR Transportation Officer. Expenses incident to the said travel may



be charged against Local Funds or any Palaro Funds subject to the usual accounting and auditing rules and regulations.

7. Coaches, trainers, chaperons and teachers will be granted service credits for every day served on weekends and for the extra hours rendered on weekdays but not to exceed five (5) days during the conduct of the Palaro. Likewise, all DepEd Officials, Regional and Division PESS Supervisors/Coordinators and staff can avail of the compensatory off credits, not to exceed five days during the conduct of the Palaro. The guidelines on the grant of service credit and compensatory time-off (per DepEd Order No. 53, s. 2003) should be observed.
