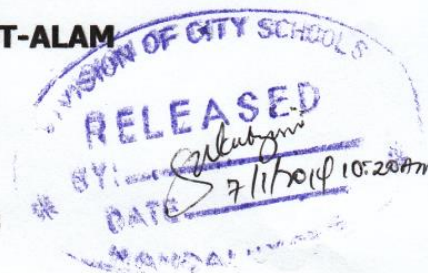

This is to formally thank you for your cooperation in the mapping of our out-of school youth (OSY) throughout the country and for the submission of the regional consolidation of the data mapped. As of June 16, 2014, we have already mapped 1,248,824, spread throughout the three tracks provided for them: education, entrepreneurship, and employment.

In order for us to have a national database of all OSYs mapped, we would like to request the regional offices to submit the list of names of the OSYs mapped, along with the other information included in the Abot-Alam Data Gathering Form. Currently, it is the National Youth Commission (NYC) that maintains the database for Abot-Alam. The maintenance of this database will be helpful for us in tracking the OSYs that we have enlisted for the program, thus, submission of this data will be very crucial.

We request for these data to be sent to NYC and DepED Central Office via email, in EXCEL file, and in the same format as that of the Abot-Alam Registration Form (Annex 1 of DepED Order NO. 17, s 2014).
