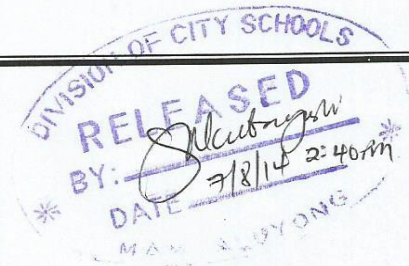

As per Memorandum from **Dr. Luz S. Almeda**, Director IV, National Capital Region, dated July 2, 2014, Strict Implementation and Observance of Safety Rules and Regulations in School Campuses to wit:

1. The well-being of our pupils/students most especially when inside the school premises is one of our main concern. Thus, the safety rules and regulations should be strictly implemented and observed at all times.
2. Schools are directed to conduct class orientation on school's safety rules and regulations during GMRC/Values Education period not later than **July 15, 2014**. Pupils/Students should be sternly warned against playing and loitering along corridors and stairways. Also make sure that corridors and stairways of multi-floor buildings have safety barricade.
3. Class Advisers of both Elementary and Secondary level are required to supervise students during recess time. **No** class should be left alone during recess time and change of session.
4. Submit Narrative Report with pupils/students attendance to the Division Office, c/o **Ms. Erdelinda G. Diaz/Mr. Eden L. Paras** before **July 18, 2014**.
