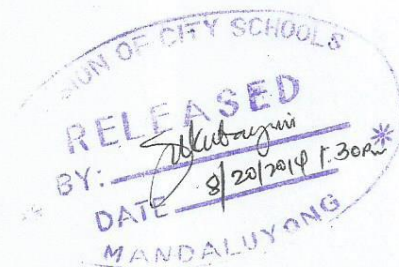

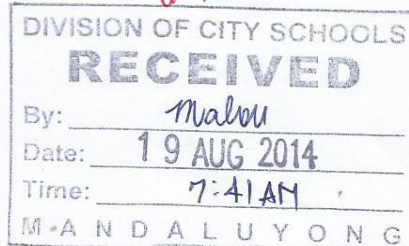

1. The Alternative Learning System Division, DepED-National Capital Region will conduct a **Five [5] - Day Live-In ALS Basic Training Course for Untrained Mobile Teachers, District ALS Coordinators, Instructional Managers and Abot-Alam Program Implementers** at the Regional Education Learning Center [RELC], Cepeda St., Concepcion Marikina City from September 1-5, 2014.
