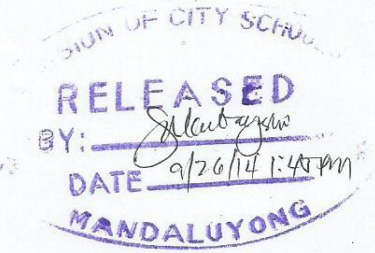


**MEMORANDUM**

TO: Education Program Supervisors  
 Principals, Public Secondary Schools


Subject: **ANNUAL BSP-DEPED ORATORICAL CONTEST**

Date: September 26, 2014



1. The Bangko Sentral ng Pilipinas (BSP) in collaboration with the Department of Education (DepEd) shall conduct the annual BSP-DepEd Oratorical Contest with the theme **"25 Years and Beyond: Solid and Responsive Statistical System in Support of Globalization and Regional Economic Integration."**
2. There will be two (2) levels of competition. The **Division Level** to be held on **October 10, 2014, 1:00 PM** at **Bonifacio Javier National High School (BJNHS)** and the **Final Competition** shall be held at the **BSP Assembly Hall, BSP Complex, Manila** (date to be announced later). Whoever ranks first in the Division level shall represent the Division of Mandaluyong City to the final competition.
3. Below are the mechanics of the contest.
  - The contest is open to any 4<sup>th</sup> year student from the public schools.
  - The Oratorical piece is delivered in English with a time limit of 6 – 7 minutes, one (1) point deduction from the contestant's total score for every minute or a fraction thereof in excess/deficit of the allotted time.
  - Topics should be in line with the theme
  - Criteria for judging

4. Prizes in the final competition shall be announced later while waiting for the Regional Memorandum.
5. It is requested that each school shall share an amount of four hundred pesos (P 400.00), to defray expenses such as medals, tokens for the judges and refreshments for the visitors. Said amount shall be charged to local school funds subject to the usual accounting and auditing procedures.
