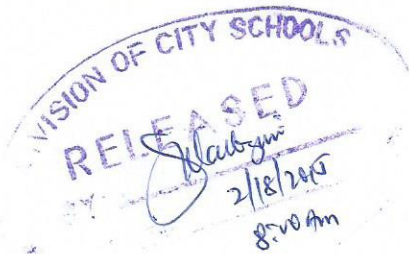
2. It has been noted that the previous BAC Members/Secretariat have served for 3-7 years. Rule V, Section II.2.6 states that:
