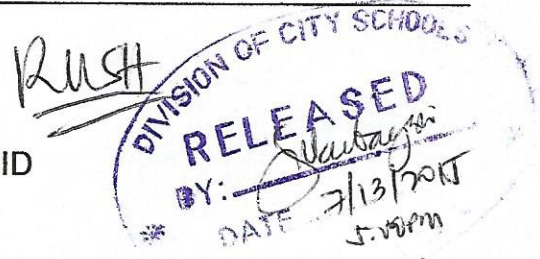



This is in reference to Republic Act 10648 otherwise known as the "Iskolar ng Bayan (INB) Act of 2014" and the Implementing Rules and Regulations for the Implementation of the INB Program, Rule III - Support to the Program, Section 1, Duties and Responsibilities, Number 1.1 letter (c), which states that, "the Department of Education (DepEd) shall identify and submit to the Commission on Higher Education (CHED) the certified list of top ten (10) graduates in each public high school..."

In line with this, All School Heads shall submit the list of the names of the top ten (10) graduates in their respective public high school following DepEd Order No. 74, s. 2012 entitled *Guidelines on the Selection of Honor Pupils and Students of Grades 1 to 10 of the K to 12 Basic Education Curriculum*.

Pursuant to RA 10648, the top ten (10) graduates shall be entitled to a scholarship in any State University and College (SUC) of their choice provided that the student has graduated within two (2) years prior to the academic year being applied for in the SUC and has complied with the application requirements of the chosen SUC.

A public high school with more than five hundred (500) graduates shall be entitled to one (1) additional scholarship slot. The additional slot shall be given to graduates whose ranks immediately follow the top ten (10) students.

All School Heads must accomplish the attached School's Top Graduates List (See Enclosure No. 1) which must be transmitted to their respective Division Offices.

The Division Offices then must submit the consolidated Schools Top Graduates list to their respective Regional Offices. (See Enclosure No. 2)

Upon consolidation of each Division's Schools Top Graduates list by the Regional Office, advanced copies of the list shall be encoded in Microsoft Word (.doc) type of document, following the attached Consolidated Schools Top Graduates List (See Enclosure No. 3).

The list shall be submitted with the file name (topgraduates-region) to youthformation@deped.gov.ph on or before July 22, 2015. The Regional Offices shall also send signed original copies of the consolidated documents to the Office of the Undersecretary for Regional Operations, DepEd Central Office, DepEd Complex, Meralco Ave., Pasig City.
