



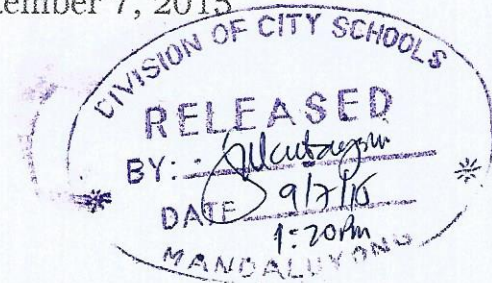



2. The functions and responsibilities of the consultative body shall include the following:
 - a. Convene regularly every three (3) months or as the need arises at such place and time that may be proposed and agreed upon by the parties;
 - b. Monitor and resolve any controversy arising from the interpretation and enforcement of this Agreement;
 - c. Prioritize the implementation of the provisions of this Agreement upon approval by the parties;
 - d. Discuss and resolve any policy changes on matters pertaining to/affecting the terms and conditions of employment; and
 - e. Recommend appropriate courses of actions to higher authority.
3. The Body shall convene immediately to formulate the implementation and monitoring schemes relative to the provisions of the Collective Negotiation Agreement (CNA).
